Giving to charity through Gift Aid

Gift Aid increases the value of donations to charities by allowing us to reclaim basic rate tax on your membership fee.

How Gift Aid works

The Gift Aid scheme is for gifts of money by individuals who pay UK tax. Gift Aid donations are regarded as having basic rate tax deducted by the donor. Nantwich Players will reclaim the basic rate tax on the membership fee from HMRC.

Your membership fee of £25 is worth £30 to Nantwich Players after gift-aid.

In certain circumstances, you may need to tell HMRC about Gift-Aid donations you have made, for instance if you fill in a tax return, so please make a note.

How to make your membership for Nantwich Players a donation using Gift Aid

In order to make a Gift Aid donation you'll need to make a Gift Aid declaration, which is done by filling in the membership form overleaf and ticking the Gift-Aid box. Nantwich Players will send this to HMRC on your behalf. HMRC will then anonymously pay the additional gift-aid income to Nantwich Players.

Nantwich Players Supporters Scheme

The Nantwich Players Supporters Scheme is for Members and you, our patrons, to help fund capital projects at the Theatre, including our digital lighting, Studio Theatre and now installation of heat pumps to be more carbon-neutral. In return for a charitable donation of £8 per month Supporters have the option of purchasing two tickets for each production before they go on sale to the public. Nantwich Players is a registered charity overseen by the Charity Commission and your £8 is worth £10 to us if you are able to Gift Aid it.

I and many others have committed to the Supporters Scheme because we want to support and develop live theatre in Nantwich and I ask you to please do the same if you possibly can. To do so, take a form from the foyer (or download from the website) and sign up. Thank you.
